The Jazz Education Network (JEN) quickly pivoted to producing online events every month to serve our members and the jazz community with relevant solutions and resources for learning how to teach and perform while sheltered at home. Although it had a negative impact on our budget due to the cancellation of our in-person conference, we were able to produce a four-day online conference despite the challenges. Our recorded webinars and online events have been viewed more than 80,000 times, expanding our reach more than ever before. Going forward, we are grateful to return to in-person but continue to serve online year round.
